TRAFFIC COMMISSIONER ANNUAL REPORT

The annual report from the Traffic Commissioners of Great Britain highlights the duties of the role and their work alongside the DVSA.

The report summarises issues within the industry, such as a shortage of drivers, and technicians - affecting both the HGV and PCV industries. Guidance in the LGV category to include vehicles between 2.5 tonne and 3.5 tonne, management CPC, Operator's management of risk and recent effect on local bus services are also assessed.

John Pitchford - SP Training will discuss the industries' skills shortage and recovery from the pandemic, specifically gaps where people have not returned.

Although there has been a great deal of focus on the driver shortage, the people behind the drivers also need to be in place to support them and ultimately the businesses they own or work for. Having people properly trained and qualified increases standards and productivity across business. This takes investment and many businesses don't realise they are not using thousands each year that they could use to support their current and up and coming staff.

Conference Speakers...

Steven Brougham of the DVSA has been a Civil Servant since 1986 firstly with the DVLA before joining VI as it was then in 1992. He has worked in an enforcement role throughout his career as Traffic Examiner, Senior Traffic Examiner and now the Enforcement Delivery Manager for the North West, North Wales, West Midlands and East Midlands.



Steven has teams of examiners who conduct roadside inspections on HGV's, PSV's and LGV's issuing prohibitions, fixed penalties and immobilising vehicles. The examiners also conduct maintenance and drivers hours investigations, presenting cases at court and at PI.

Steven will be discussing Risk, that is the risk to yourself and other road users, the risk to your livelihood and reputation and risk avoidance (preventative maintenance, journey planning, driver training, inspection frequency).

Gerallt Evans was appointed as **Traffic Commissioner for the North West** of England in February 2020.



Gerallt worked in private practice in North Wales after qualifying as a solicitor. He joined the Crown Prosecution Service in 1992 and worked as a frontline prosecutor dealing with the full range of criminal prosecution work before moving into management roles. In 2014, Gerallt was appointed Deputy Chief Crown Prosecutor for CPS London with responsibility for all Magistrates' Court and domestic abuse prosecutions throughout the capital. Three years later he returned to Wales in the same role. During his career at the CPS, Gerallt was involved in developing policy on prosecuting road traffic cases as well as acting as a national lead on prosecuting hate crimes and wildlife and heritage crime. Gerallt was also involved in various projects to improve the efficiency of the criminal justice system including the introduction of digital working.

WHAT IS DVS?



DVS, the Direct Vision Standard and safety permit scheme for heavy goods vehicles (HGVs), requires operators of lorries over 12 tonnes gross vehicle weight to obtain a safety permit before entering and operating in most of Greater London. Otherwise, you may receive a Penalty Charge Notice (PCN) of up to £550 per day.


The **Direct Vision Standard** measures how much an HGV driver can see directly through their cab windows. This indicates the level of risk to vulnerable road users, such as people walking and cycling, near the vehicle.

The Direct Vision Standard and HGV safety permit for HGVs is part of the <u>Mayor of London's Vision Zero plan</u> to eliminate all deaths and serious injuries on London's transport network by 2041.

The HGV safety permit scheme covers most of Greater London and is in operation 24 hours a day, every day of the year. <u>Applying for a permit</u> is free of charge.

DVSA LOAD SECURITY CODE OF PRACTICE

The DVSA have launched a new **code of practice** for load security. This is to help hauliers understand the parameters in loading and unloading goods safely. NATIONAL SHORTAGE OF PCV DRIVERS

National research by **SP Training** has highlighted the shortage of PCV (Coach/Bus) drivers in the industry, which has not seen any benefit of Skills Bootcamp related funding targeted at filling the HGV driver shortage.

To combat this, they have launched a Level 2 PCV (Bus & Coach) Apprenticeship, allowing businesses to access a minimum of 95% funding from the apprenticeship levy. The funding not only funds the Category D driving licence, but also the required Driver CPC to carry passengers for Hire or reward.
