





## LEVEL 3 TRANSPORT SUPERVISOR

This is a blended apprenticeship programme suitable for employees working for employers in the transport/haulage industry. Learners on this programme would currently be employed to lead a team and have regular engagement with customers. This would suit newly promoted **Transport Supervisors**, **Depot Supervisors**, **Transport Coordinators** and **Traffic Planners**.

With delivery via Tutor led virtual classroom sessions, group work, online learning and 1-2-1 workshops, this **12-16 month** programme will cover a variety of core transport related units. The result will be the acquisition of the knowledge and skills required to operate as a highly competent, compliant and industry skilled **Transport Supervisor**.

#### WHAT WILL BE COVERED?

Knowledge acquired will include but is not limited to;

Recruitment & selection, appraisals & staff performance management Operating Licence legislation Understanding operator compliance risk score systems Rules and best practice for sector specific operations Management CPC knowledge Vehicle maintenance & fleet operations Drivers' hours and record keeping Project planning Risk Assessment Efficiency improvement

The Apprenticeship includes training in and completion of Level 3 Certificate of Professional Competence for Transport Managers (MCPC)

IT & Systems Management Business Improvement Risk Assessments Vehicle Maintenance & Compliance Fuel Costings & Scheduling Staff management


## **COURSE DETAILS**

This learning element of the course will be delivered over a **12 months**, where the learner will work full-time for their employer and attend theory-based lessons delivered by an expert subject Tutor, Marie Kerwick.

There is then an **End Point Assessment** element which takes place after the 12 months of learning. This includes an improvement project in the form of a 4,000 word report so the learner must have the opportunity to carry this out. The EPA takes up to 4 months.

## **ENTRY REQUIREMENTS**

The learner must be exposed to relevant work experience in their current role to be able to meet the standards of the apprenticeship.

We require all candidates to hold (and show proof of) a minimum of a GCSE grade C/4/functional Skills level 2 in at least one of the following subject areas before enrolment; Maths and English.

For those who need to complete either Maths or English at grade C, **Functional Skills tuition** is available from our specialist tutors, who will support you to complete the final exam.

If a candidate requires functional skills support they will be required to take an initial assessment to determine whether they are eligible to be enrolled on programme.

### **PROGRAMME DELIVERY**

#### **ASSESSMENT METHODS**



Learners will be subject to an End Point Assessment (EPA) which will consist of;

A multiple-choice test of 25 questions over 60 mins A project report (max 4000 words) based on a real-life or recurring organisational issue, a specific problem or an idea/opportunity A presentation (15 mins) and a minimum of 5 questions (25 mins) An interview to assess learner competence against the knowledge, skills and behaviours gained across the program.

#### WHAT'S NEXT?

Upon successful completion of this level 3 apprenticeship the learner may go on to apply for positions within your business at **Transport or Operations Manager** level.
