Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction initiatives.

We project that carbon emissions will decrease over the next five years by 30% .

Our predominate carbon emission source is our LGV training fleet and we are taking measures to ensure all of our fleet is converted fully to Euro 6 by January 2026

Our trailers will be converted to fuel efficient design by June 2025

CPD activities for training staff include Fuel efficient driving techniques to ensure trainees use these skills when operating in their own fleets.

We have implemented greater home working which will reduce staff commuting by 25% by December 2025.

We have a dedicated Carbon Reduction Champion who is at Director level

All interior lighting will be low energy and on PIR sensor by February 2024
